# 4. COMPLETING AND SUBMITTING A PROPOSAL

- 4.1. Your Proposal must consist of the following three documents:
  - Signed Declaration of Undertaking (see Attachment 2)
  - Technical Proposal (see Section 4.4 below)
  - Financial Proposal (see Section 4.5 below)

Proposals must be prepared in English.

4.2. Your Proposal must be submitted by email to the IUCN Contact (see Section 2). The subject heading of the email shall be [RfP Reference – bidder name]. The bidder name is the name of the company/organisation on whose behalf you are submitting the proposal, or your own surname if you are bidding as a self-employed consultant. Your proposal must be submitted in PDF format. You may submit multiple emails suitably annotated, e.g. Email 1 of 3, if attached files are too large to suit a single email transmission. You may not submit your Proposal by uploading it to a file-sharing tool.

<u>IMPORTANT:</u> Submitted documents <u>must be password-protected</u> so that they cannot be opened and read before the submission deadline. Please use the same password for all submitted documents. <u>After</u> the deadline has passed and within 12 hours, please send the password to the IUCN Contact. This will ensure a secure bid submission and opening process. Please DO NOT email the password before the deadline for Proposal submission.

# 4.3. Eligibility

# 4.4. Technical Proposal

The technical proposal must address each of the criteria stated below explicitly and separately, quoting the relevant criteria reference number (left-hand column).

Proposals in any other format will significantly increase the time it takes to evaluate, and such Proposals may therefore be rejected at IUCN's discretion.

Where CVs are requested, these must be of the individuals who will carry out the work specified. The individuals you put forward may only be substituted with IUCN's approval.

# 4.5. Financial Proposal

4.5.1. The financial proposal must be a fixed and firm price for the provision of the goods/services stated in the RfP in their entirety.

# 4.5.2. Prices include all costs

Submitted rates and prices are deemed to include all costs, insurances, taxes (except VAT, see below), fees, expenses, liabilities, obligations, risk and other things necessary for the performance of the Terms of Reference or Specification of Requirements. IUCN will not accept charges beyond those clearly stated in the

Financial Proposal. This includes applicable withholding taxes and similar. It is your responsibility to determine whether such taxes apply to your organisation and to include them in your financial offer.

# 4.5.3. Applicable Goods and Services Taxes

Proposal rates and prices shall be exclusive of Value Added Tax.

- 4.6. Additional information not requested by IUCN should not be included in your Proposal and will not be considered in the evaluation.
- 4.7. Your proposal must remain valid and capable of acceptance by IUCN for a period of 90 calendar days following the submission deadline.

# 4.8. Withdrawals and Changes

You may freely withdraw or change your proposal at any time prior to the submission deadline by written notice to the IUCN Contact. However, to reduce the risk of fraud, no changes or withdrawals will be accepted after the submission deadline.

#### 5. EVALUATION OF PROPOSALS

# 5.1. Completeness

IUCN will firstly check your proposal for completeness. Incomplete proposals will not be considered further.

# 5.2. Technical Evaluation

# 5.2.1. Scoring Method

Your proposal will be assigned a score from 0 to 10 for each of the technical evaluation criteria, such that '0' is low and '10' is high.

# 5.2.2. Minimum Quality Thresholds

Proposals that receive a score of '0' for any of the criteria will not be considered further.

#### 5.2.3. Technical Score

Your score for each technical evaluation criterion will be multiplied with the respective relative weight (see Section 4.4) and these weighted scores added together to give your proposal's overall technical score.

# 5.3. Financial Evaluation and Financial Scores

The financial evaluation will be based upon the full total price you submit. Your financial proposal will receive a score calculated by dividing the lowest financial proposal that has

passed the minimum quality thresholds (see Section 5.2.2) by the total price of your financial proposal.

Thus, for example, if your financial proposal is for a total of CHF 100 and the lowest financial proposal is CHF 80, you will receive a financial score of 80/100 = 80%

#### 5.4. Total Score

Your proposal's total score will be calculated as the weighted sum of your technical score and your financial score.

The relative weights will be:

Technical: 70% Financial: 30%

Thus, for example, if your technical score is 83% and your financial score is 77%, you will receive a total score of 83 \* 70% + 77 \* 30% = 58.1% + 23.1% = 81.2%.

Subject to the requirements in Sections 4 and 7, IUCN will award the contract to the bidder whose proposal achieves the highest total score.

#### 6. EXPLANATION OF PROCUREMENT PROCEDURE

- 6.1. IUCN is using the Invitation Procedure for this procurement. This means that only invited bidders may submit a proposal. IUCN typically invites from four to six bidders to submit a proposal.
- 6.2. You are welcome to ask questions or seek clarification regarding this procurement. Please email the IUCN Contact (see Section 2), taking note of the deadline for submission of questions in Section 3.1.
- 6.3. All proposals must be received by the submission deadline in Section 3.1 above. Late proposals will not be considered. All proposals received by the submission deadline will be evaluated by a team of two or more evaluators in accordance with the evaluation criteria stated in in this RfP. No other criteria will be used to evaluate proposals. The contract will be awarded to the bidder whose proposal received the highest Total Score. IUCN does, however, reserve the right to cancel the procurement and not award a contract at all.
- 6.4. IUCN will contact the bidder with the highest-scoring proposal to finalise the contract. We will contact unsuccessful bidders after the contract has been awarded and provide detailed feedback. The timetable in Section 3.1 gives an estimate of when we expect to have completed the contract award, but this date may change depending on how long the evaluation of proposals takes.

# 7. CONDITIONS FOR PARTICIPATION IN THIS PROCUREMENT

- 7.1. To participate in this procurement, you are required to submit a proposal, which fully complies with the instructions in this RfP and the Attachments.
  - 7.1.1. It is your responsibility to ensure that you have submitted a complete and fully compliant proposal.
  - 7.1.2. Any incomplete or incorrectly completed proposal submission may be deemed non-compliant, and as a result you may be unable to proceed further in the procurement process.
  - 7.1.3. IUCN will query any obvious clerical errors in your proposal and may, at IUCN's sole discretion, allow you to correct these, but only if doing so could not be perceived as giving you an unfair advantage.
- 7.2. To participate in this procurement, you must meet the following conditions:

- Free of conflicts of interest
- Registered on the relevant professional or trade register of the country in which you are established (or resident, if self-employed)
- In full compliance with your obligations relating to payment of social security contributions and of all applicable taxes
- Not been convicted of failing to comply with environmental regulatory requirements or other legal requirements relating to sustainability and environmental protection.
- Not bankrupt or being wound up.
- Never been guilty of an offence concerning your professional conduct.
- Not involved in fraud, corruption, a criminal organisation, money laundering, terrorism, or any other illegal activity.
- 7.3. You must complete and sign the Declaration of Undertaking (see Attachment 2)
- 7.4. If you are participating in this procurement as a member of a joint venture, or are using subcontractors, submit a separate Declaration of Undertaking for each member of the joint venture and sub-contractor, and be clear in your proposal which parts of the goods/services are provided by each partner or sub-contractor.
- 7.5. Each bidder shall submit only one proposal, either individually or as a partner in a joint venture. In case of joint venture, one company shall not be allowed to participate in two different joint ventures in the same procurement nor shall a company be allowed to submit a proposal both on its behalf and as part of a joint venture for the same procurement. A bidder who submits or participates in more than one proposal (other than as a subcontractor or in cases of alternatives that have been permitted or requested) shall cause all the proposals with the bidder's participation to be disqualified.
- 7.6. By taking part in this procurement, you accept the conditions set out in this RfP, including the following:
  - It is unacceptable to give or offer any gift or consideration to an employee or other representative of IUCN as a reward or inducement in relation to the awarding of a contract. Such action will give IUCN the right to exclude you from this and any future procurements, and to terminate any contract that may have been signed with you.
  - Any attempt to obtain information from an employee or other representative of IUCN concerning another bidder will result in disqualification.
  - Any price fixing or collusion with other bidders in relation to this procurement shall give IUCN the right to exclude you and any other involved bidder(s) from this and any future procurements and may constitute a criminal offence.

# 8. CONFIDENTIALITY AND DATA PROTECTION

- 8.1. IUCN follows the European Union's General Data Protection Regulation (GDPR). The information you submit to IUCN as part of this procurement will be treated as confidential and shared only as required to evaluate your proposal in line with the procedure explained in this RfP, and for the maintenance of a clear audit trail. For audit purposes, IUCN is required to retain your proposal in its entirety for 10 years after the end of the resulting contract and make this available to internal and external auditors and donors as and when requested.
- 8.2. In the Declaration of Undertaking (Attachment 2) you need to give IUCN express permission to use the information you submit in this way, including personal data that forms part of your proposal. Where you include personal data of your employees (e.g. CVs) in your proposal, you need to have written permission from those individuals to share this information with IUCN, and for IUCN to use this information as indicated in 8.1. Without these permissions, IUCN will not be able to consider your proposal.

#### 9. COMPLAINTS PROCEDURE

# 10. CONTRACT

# **Background**

The International Union for the Conservation of Nature (IUCN) is the world's leading conservation membership union established in 1948 and composed of over 1,400-member organizations of both government and civil society organizations with the input of more than 18,000 experts. IUCN's mission is to influence, encourage and assist societies to conserve the integrity and diversity of nature and ensure that any use of natural resources is equitable and ecologically sustainable. Through its Regional Office for West Asia (ROWA) and related global programmes, IUCN is seeking to strengthen its presence in the Kingdom of Saudi Arabia on initiatives that align with IUCN's mission and priorities.

IUCN ROWA is currently implementing the AlUla Protected Area Network (APAN) project in AlUla, Medina Province (located in Northwest Saudi Arabia), in partnership with the Royal Commission for AlUla (RCU). The APAN project is aiming to establish and initiate a well-connected, fairly governed, and effectively managed network of protected and conserved areas that adheres to international standards and best-practices, shares lessons, brings successful regional and global approaches, and demonstrates initial success in nature conservation, restoration, and sustainable use of ecosystems and natural resources for people and biodiversity. IUCN-ROWA has established a project management unit for this project which includes staff based in IUCN-ROWA (Jordan), and in KSA.

Through this partnership project, IUCN and RCU are addressing key threats affecting AlUla's landscape and strengthening the socio-economic and environmental benefits arising from sound protection and management of AlUla's protected areas. This project sees the world's international standards and practices implemented in AlUla's protected areas, with the professional assistance of IUCN's regional and international experts. AlUla's bid to present authentic tourism experiences will be grounded in a world-class system of protected areas. Hence, this project supports the governance and management of AlUla's biodiversity and protected areas in accordance with IUCN international standards and best practices. RCU has recently designated six new protected areas: Sharaan Nature Reserve as well as the Harrat Uwayrid, Harrat Alzabin, Wadi Nakhla, AlGharameel, and Harrat Khaybar.

#### **Scope of Work and Objectives**

Under the supervision of the Senior Project Coordinator / Protected Areas, World Heritage and Business Programme – AlUla (IUCN ROWA), and in coordination and consultation with the Royal Commission for AlUla (RCU), the consultant shall provide the following services:

- Contribute to and support the implementation of **Component 3: Ecosystem rehabilitation and support for species reintroductions** for (AlUla PAN) Project, in coordination with the project coordinator and component leader.

IUCN: Request for Proposals

The consultant shall ensure the delivery of the outputs and activities and shall refer to the activity description in the project document (version May 2022).

The consultant shall be responsible for the following specific tasks under the following relevant components:

Support the implementation of Component 3: Ecosystem rehabilitation and support for species reintroductions

Supporting the delivery of Component 3: Ecosystem rehabilitation and support for species reintroductions

Outcome: Enhanced habitat rehabilitation for key ecosystems in important areas, including connectivity zones, using scientifically-based native species reintroduction approaches.

Under Output 3.1: Optimal sites for habitat rehabilitation and species reintroductions are defined

**Activity 3.1.2**: Assess carrying capacity to ensure feasibility of the Cheetah habitat rehabilitation and reintroduction / translocation project. Role: Assess the carrying capacity for the Cheetah habitat rehabilitation and reintroduction / translocation for the AlUla PA network – at the wider landscape level, with the support of and under the supervision of the biodiversity team leader, and in collaboration with the focal person designated by RCU. The carrying capacity study should aim to cover the following aspects:

- The African Asiatic Cheetah (*Acinonyx jubatus*) reintroduction programme will consider the carrying capacity to maintain optimal viable populations of the Cheetah. Simulation modelling will be applied to estimate the optimal population of Cheetah, by integrating variables like natural growth rate, natural mortality rate, loss due to hunting and other threats, availability of prey, habitat capacity, and other variables. The consultant shall build on the findings of the rapid biodiversity assessment and the SDM work conducted under other project components.
- RCU is undertaking a five-years rangeland carrying capacity project and an inventory of flora and fauna. The consultant should advise IUCN to ensure that this activity aligns with the existing project and any results achieved under the IUCN project will inform the longer-term rangeland carrying capacity project.

**Under Output 3.2:** Wildlife reintroduction strategies and management plans are developed and implemented with operational plans.

**Activity 3.2.2**: Prepare a strategy, and an implementation and operational plan for the re-introduction / translocation of the Cheetah. Role: Design implementation and operational plans for the Cheetah with the support and under the supervision of the biodiversity team leader, and in collaboration with the focal person designated by RCU. The design of the implementation and operational plans for keystone species should aim to cover the following aspects:

- This activity focuses on the specific implementation and operational plans to support re-introductions / translocations for the Cheetah.
- The plan would vary depending upon complexity, and may include the following:
  - Specific implementation objectives and targets. The project should be designed using an adaptive management approach.
  - Specie(s) to be released, number of individuals, location and timeframe.

- Risk assessment and ecological consequences of the reintroduction or translocation (biological traits of the species source area, ecological conditions in the destination area, inter-specific competition, predation, disease, habitat response, etc.).
- Alternatives and mitigations.
- Detailed list of actions and timeline prior to, during, and following the release.
- Personnel roles and responsibilities for RCU staff in management, technical, scientific, community relations, media, and others.
- Specific monitoring activities and protocols to be followed and for how long (enables measuring against objectives, assessing impacts, adjusting management, identification of new threats, monitoring behaviour of the individual animals and progress in adapting to the new ecosystem, genetic monitoring, health, and mortality monitoring).
- Equipment needs (vehicles, air support, tracking equipment, etc.).
- The specific means for engaging local community partners, e.g., participation on social, cultural, and economic monitoring can engender support and be used to assess attitudes towards the project.
- o Budget
- o Evaluation of the project and lessons learnt to inform future projects.
- Means and timing of reporting and sharing information (promotes awareness, contributes to local support, body of knowledge for future work).
- It is anticipated that targeted herbivores would be initial priorities, and once habitat and herbivore rehabilitation is achieved, more complex predator reintroductions can be undertaken.

# **Deliverables**

The consultant shall submit the following to IUCN-ROWA:

Component 3: Ecosystem rehabilitation and support for species reintroductions for (AIUIa PAN) Project

**Outcome:** Enhanced habitat rehabilitation for key ecosystems in important areas, including connectivity zones, using scientifically-based native species reintroduction approaches.

Under Output 3.1: Optimal sites for habitat rehabilitation and species reintroductions are defined

**Activity 3.1.2**: Assess carrying capacity to ensure feasibility of the Cheetah habitat rehabilitation and reintroduction / translocation project. (1 carrying capacity study for the Cheetah habitat rehabilitation and reintroduction for the AlUla PA network)

**Under Output 3.2:** Wildlife reintroduction strategies and management plans are developed and implemented with operational plans.

**Activity 3.2.2**: Prepare a strategy, and an implementation and operational plan for the re-introduction / translocation of the Cheetah. (1 strategy for the reintroduction / translocation of the Cheetah, 1 implementation and operational plan for the reintroduction of the Cheetah)

The consultant shall refer to the detailed description of each deliverable in the project document.

# **Payment Schedule**

The consultant is expected to conduct the work within an estimated 30 working days between April and June 2023 through office work, field work, and consultation with the IUCN ROWA and relevant stakeholders if needed. The consultant shall submit an invoice according to the schedule of payments described below:

- 1. 25% upon signature
- 2. 15% upon the completion of deliverable (3.1.2), 10 May 2023
- 3. 20% upon the completion of a strategy for the Cheetah reintroduction (3.2.2), 30 May 2023
- 4. 15% upon the completion of an implementation and operational plan for the reintroduction of the Cheetah (3.2.2), 10 June 2023
- 5. 25% upon the completion of the remaining deliverable (3.2.2), and all tasks and delivery of all relevant deliverables and reports, 25 June 2023

The consultant will be responsible for all taxes related to this agreement, If the consultant is subject to tax in the territory of Jordan in respect of the consideration received under this agreement, the consultant hereby acknowledges that IUCN is entitled to deduct 5% for residents of Jordan and 10% for residents outside Jordan, in addition to 1% as national contribution for non-residents, as income tax arising or made in connection with this agreement, as well as a 5% administrative and review cost arising or made in connection with this agreement.

#### **Qualifications of Successful Candidate**

The individual consultant, consulting firm or organization should provide a team of experts covering the following qualifications and expertise:

- MSc or PhD degree in environmental sciences, environmental management, biodiversity conservation, or any other related fields (a PhD degree is preferred).
- Extensive and practical knowledge of main environmental agreements and environmental policies.
- Extensive experience, proven record of applying systematic wildlife conservation planning.
- Extensive experience, proven record of designing wildlife reintroduction programmes.

- Experience, proven record of felids and / or large carnivores' conservation.
- Between 15 to 20 years of experience with conservation planning and protected areas.
- At least 10 years of experience with project implementation in large-scale regional projects or with international organizations.
- Demonstrated expertise and experience in the field of conservation, specifically in West Asia.
- Experience in communicating and collaborating with management agencies, academic institutions, and local, national, and regional stakeholders to achieve agreed collective outcomes.
- Experience in biodiversity and/or protected areas information management, ideally involving terrestrial ecosystems, at national and/or regional levels.
- Ability to compile large amounts of information succinctly into a coherent document for conservation practitioners and government officials.
- Excellent facilitation and coordination skills, with the ability for managing the timely and effective delivery of both quantity and quality work on time.
- Strong communication and presentation skills, and an ability to prepare appropriate and timely reports to a wide range of audiences and cultures.
- Excellent time management skills, including an ability to work effectively under pressure and to meet tight deadlines.
- Excellent writing and speaking literacy in English (Arabic is an asset).
- Proven ability to liaise and work with a range of stakeholders including government agencies, the private sector, and local communities, and in support of regional and national institutions.
- Demonstrated commitment to achieving biodiversity conservation and livelihoods goals.
- A team player able to contribute effectively to collaborative issues, and to demonstrate innovation and leadership.

# CONSULTANCY AGREEMENT (the "Agreement")

#### between

**IUCN, International Union for Conservation of Nature and Natural Resources**, an international association established under the laws of Switzerland, with its World Headquarters located at Rue Mauverney 28, 1196 Gland, Switzerland (hereafter "**IUCN**"),

#### and

#### **PREAMBLE**

#### 1. SERVICES

- 1.3 IUCN reserves the right to request any reports (progress, financial or otherwise additional to those required under the Agreement), which could be considered to be reasonably required to evidence satisfactory

performance under the Agreement. All financial records and other relevant documents relevant to or pertaining to this Agreement may be subject to inspection and/or audit at the discretion of IUCN or of the Donor. The Consultant agrees to allow IUCN or Donor's auditor(s) access to such records during normal business hours and to allow interviews of any employees who might reasonably have information related to such records. In the event of inspection or audit, IUCN or Donor shall provide the Consultant reasonable prior written notice.

1.4 The Consultant shall not subcontract the Services to third parties without the prior written consent of IUCN. However, the Consultant may under its own responsibility use the services of others provided such services are of an auxiliary or clerical nature.

#### 2. TERM

#### 3. INDEPENDENT STATUS

- 3.1 The employees, directors or shareholders of the Consultant shall not be entitled to any pension, bonus or other fringe benefits from IUCN.

## 4. OBLIGATIONS

- 4.1. The Consultant shall carry out its duties in an expert and diligent manner and to the best of its ability and shall promptly and faithfully comply with all lawful and reasonable requests which may be made by the IUCN Contact Person.
- 4.2. The Consultant shall give written or oral advice or information regarding the execution of the Services as and when required by IUCN.
- 4.3. In the case of illness or accident or a case of Force Majeure as described under clause 16.3 preventing the Key Personnel from performing the Services, the Consultant shall promptly notify IUCN in writing of impediment.

#### 5. REMUNERATION

# 7. CONSULTANT'S WARRANTIES AND UNDERTAKINGS

- 7.1 The Consultant warrants that its performance of the Services under the terms of this Agreement will not infringe on the rights of any third party or cause the Consultant to be in breach of any obligation towards a third party.
- 7.2 The Consultant warrants that it has obtained the assignment of all Results and Intellectual Property rights pertaining to the Results from his employees (including without limitation the Key Personnel).
- 7.3 The Consultant shall maintain at its sole expense liability and any other relevant insurance covering the performance of this Agreement. IUCN may require the Consultant to provide a certificate of insurance evidencing such coverage.
- 7.4 The Consultant represents and warrants that no part of the Remuneration shall be provided to, or used to support, individuals and organizations associated with terrorism as identified on any sanction list published by

the European Union, the United States Government, the United Nations Security Council or other relevant agency or body.

#### 8. CONFIDENTIALITY

- 8.1 The Consultant will not disclose or use, at any time during or subsequent to this Agreement, any confidential information of IUCN or any other non-public information relating to the business, financial, technical or other affairs of IUCN except as required by IUCN in connection with the Consultant's performance of this Agreement or as required by law. In particular, but without prejudice to the generality of the foregoing, the Consultant shall keep confidential all Intellectual Property and know-how disclosed to it by IUCN, which becomes known to it during the period of this Agreement or which it develops or helps to develop in providing the Services to IUCN.
- 8.2 The Consultant may communicate confidential information only to those of its employees who are directly and necessarily involved in the performance of this Agreement or who are bound to the Consultant by obligations no less stringent as the ones mentioned in this Agreement.
- 8.3 The Consultant shall:
  - 8.3.1 not disclose to third parties (including news and social media) without express prior written consent of IUCN the contents of this Agreement and the results of work performed as part of the provision of the Services:
  - 8.3.2 disclose know-how and other confidential information of IUCN which is provided by IUCN to the Consultant for the purpose of carrying out the Services only to those persons necessary to accomplish the Services and only to the extent necessary for the proper performances of the Services or to persons bound to the Consultant by obligations no less stringent as the ones mentioned in this Agreement.
- 8.4 The Consultant agrees to immediately notify IUCN in writing if it becomes aware of any disclosure in breach of the obligations of this clause 8. ### 9. PROPERTY OF RESULTS

At any time, even after the termination of this Agreement, the Consultant shall, upon request, promptly deliver to IUCN all such tangible items which are in its possession or under its control and relate to IUCN, its business affairs and clients and/or the Services.

- 10.1 Intellectual Property rights are any and all rights and prerogatives, registered or not, arising from the Swiss and international legislation on the protection of notably patents, design, trademark, as well as know-how and trade secrets.

the full duration of such rights, including, without any limitations, the right to use, publish, license, translate, sell or distribute, privately or publicly, any item or part thereof wherever in the world enforceable.

- 10.4 The Consultant confirms that IUCN shall have all rights of development, manufacture, promotion, distribution and exploitation in relation to the projects undertaken and products developed in the course of the provisions of the Services and the Intellectual Property created or arising from the provision of the Services.
- 10.5 Neither Party shall have the right to use the other Party's name, logo and/or other trademarks in any medium and for whatever purpose without the other Party's prior written consent in each instance of use.

#### 11. LIABILITY AND INDEMNITY

- 11.1 IUCN shall not be held liable for any damage caused or sustained by the Consultant, including any damage caused to its employees and / or third parties as a consequence of or during the provision of the Services or the implementation of the Present Agreement.
- 11.2 The Consultant agrees to indemnify and hold IUCN harmless from any and all losses and damages that IUCN may incur as a result of Consultant's actions or omissions in rendering the Services or the breach of any of the Consultant's obligations contained in this Agreement.

#### 12. COMMUNICATION AND NOTICES

# 13. ETHICS, FRAUD AND CORRUPTION

- 13.1 The Consultant shall comply with the principles and expected standards of conduct equivalent to those stipulated in Section 4 of the Code of Conduct and Professional Ethics for the Secretariat, available at <a href="https://www.iucn.org/downloads/code">https://www.iucn.org/downloads/code</a> of conduct and professional ethics.pdf, which by signing this Agreement, the Consultant confirms it has reviewed and accepted.
- 13.2 The Consultant shall take all necessary measures to prevent any situation where the impartial and objective implementation of the Agreement is compromised for reasons involving economic interest, political or national affinity, family or emotional ties or any other shared interest.
- 13.3 The Consultant represents and warrants that there are no potential or actual conflicts of interests in relation to the implementation of this Agreement. If, during the course of this Agreement, the Consultant becomes aware of facts which constitute or may give rise to a conflict of interest, the Consultant shall promptly inform the IUCN Contact Person in clause 12.1 in writing, without delay. The Consultant shall immediately take all the necessary steps to rectify this situation. IUCN reserves the right to verify that the measures taken are appropriate and may require additional measures to be taken within a specified deadline.

- 13.4 The Consultant shall take all necessary precautions to avoid fraud and corrupt practices in implementing this Agreement. The Consultant shall comply with the standards of conduct equivalent to those stipulated in IUCN's Anti-fraud Policy, available at <a href="https://www.iucn.org/downloads/anti\_fraud\_policy.pdf">https://www.iucn.org/downloads/anti\_fraud\_policy.pdf</a>, which by signing this Agreement, the Consultant confirms it has reviewed and accepted.
- 13.5 The Consultant shall cooperate fully in any investigations linked to events under this clause which may be carried out by IUCN and/or the Donor and shall give access to all records (and to its staff if applicable) in the event that this is needed to support investigations of complaints of unethical behavior, fraud or corruption. IUCN reserves the right to take necessary legal action and/or terminate the Agreement in accordance with clause 16 if it determines that any fraud, corruption and/or unethical behaviour has occurred. Any repayment claim may also include interest, investment income or any other financial gain obtained as a result of the fraud.

# 14. NON-DISCRIMINATION AND POLICY ON THE PROTECTION FROM SEXUAL EXPLOITATION, SEXUAL ABUSE, AND SEXUAL HARASSMENT (SEAH POLICY)

- 14.1 IUCN recommends the Consultant to apply non-discriminatory practices in terms of benefits and remuneration for both men and women employees in the performance of this Agreement.
- 14.2 The Consultant will comply with the principles and standards of protection equivalent to those stipulated in the SEAH Policy available at https://www.iucn.org/sites/dev/files/seah\_revised\_version\_2020apr27.pdf

#### 15. PROCESSING OF PERSONAL DATA

- 15.1 Personal Data is any information relating to an identified or identifiable individual, unless otherwise defined under applicable law. The Parties commit themselves to respect applicable data protection laws and regulations and process Personal Data in accordance with the terms of this Agreement.
- 15.2 IUCN may share Personal Data of the Consultant and / or Consultant Key Personnel with the Donor and other IUCN partners strictly involved in the implementation of the Project. The Consultant will have the right of access its Personal Data and the right to rectify any such Personal Data held by IUCN. If the Consultant has any queries concerning the processing of Personal Data, it shall address them to IUCN using the online form located at (https://portals.iucn.org/dataprotection/requestform).
- 15.3 IUCN may in the course of performance of this Agreement provide the Consultant with Personal Data. The Consultant shall limit access and use of Personal Data to that strictly necessary for the performance of this Agreement and shall adopt all appropriate technical and organizational security measures necessary to preserve the strictest confidentiality and limit access to Personal Data.
- 15.4 Where the Consultant engages another processor for carrying out specific processing activities on behalf of IUCN, the same data protection obligations as set out in this Agreement and the applicable law shall be imposed on that other processor by way of an agreement. Where that other processor fails to fulfil its data protection obligations, the Consultant shall remain fully liable to IUCN for the performance of that other processor's obligations.
- 15.5 Where Personal Data is transferred to a country that has not been deemed to provide an adequate level of protection for Personal Data or to an International Organization within the meaning of Regulation (EU) 2016/679, the Consultant shall ensure that appropriate safeguards in accordance with applicable law are provided.

15.6 The Consultant shall promptly, and in any case within twenty-four (24) hours inform IUCN through the online form located at (https://portals.iucn.org/dataprotection/requestform), if it determines and/or discloses to a competent public authority and/or affected data subjects that a Personal Data breach has occurred.

#### 16. TERMINATION

- 16.1 Termination for cause
- 16.1.1 IUCN reserves the right to terminate this Agreement in whole or in part, upon written notice with immediate effect in the event that the Consultant:
- i. has falsified or provided inaccurate, incomplete or misleading information in any documentation provided to IUCN:
- ii. defaults in carrying out any of its obligations under this Agreement;
- iii. has engaged in illegal acts, including, without limitation fraudulent or corrupt actions as defined in Code of Conduct and Professional Ethics for the Secretariat and IUCN's Anti-fraud Policy (hereafter referred to as a "Fraud"):
- iv. enters into liquidation or dissolution other than for the purpose of an amalgamation or reconstruction; or
- v. ceases to carry on business, has a receiver or administrator appointed over all or any part of its assets or undertaking, enters into any composition or arrangement with its creditors or takes or suffers any similar action in consequence of a debt or other liability, or undergoes any process analogous to the foregoing in any jurisdiction throughout the world.
- 16.1.2 If it is determined that the Consultant has committed Fraud in competing for or in the performance of this Agreement, all expenditures incurred under this Agreement shall be undue and the Consultant shall promptly reimburse IUCN for all expenditures incurred in the performance of this Agreement.
- 16.2 Termination for lack of Donor funds

IUCN shall have the right to terminate this Agreement with immediate effect and without any liability for damages to the Consultant in case the agreement between IUCN and the Donor is terminated and/or the Remuneration funds become unavailable to IUCN.

- 16.3 Termination for force majeure
- 16.3.1 The performance of this Agreement by either Party is subject to acts of God, war, government regulations, epidemics, pandemics, disaster, strikes (excluding strikes of respective Parties' personnel), civil disorders, curtailment of transportation facilities, or other emergencies making it illegal or impossible for either Party to perform its obligations ("Force Majeure Event"). The Party subject to a Force Majeure Event shall promptly notify the other Party of the occurrence and particulars of such Force Majeure Event, including how it impacts the performance of its obligations under this Agreement. The Party so affected shall use diligent efforts to avoid or remove such causes of non or delayed performance as soon as is reasonably practicable.
- 16.3.2 This Agreement may be terminated unilaterally without compensation for any one or more of the foregoing reasons by written notice from one Party to the other.
- 16.3.3 Notwithstanding the above, the Parties may agree to a suspension or an extension of the Agreement as deemed appropriate. Upon termination of the Force Majeure Event, the performance of the suspended Services shall without delay recommence.
- 16.3.4 The Party subject to the Force Majeure Event shall not be liable to the other Party for any damages arising out of or relating to the suspension or termination of Services by reason of the occurrence of a Force Majeure Event, provided such Party complies with all the requirements under this article 16.3.

#### 16.4 Effects of Termination

In the event of termination under this clause, IUCN shall pay the Consultant any outstanding Remuneration in respect of Services performed by the Consultant up until the effective date of termination, it being understood that the total amount payable by IUCN to the Consultant shall not exceed the Remuneration stated in clause 5 of the Agreement. The Consultant shall within thirty (30) days of termination, and at IUCN's request:

- 16.4.1 to the extent possible, complete the Services subject to the Remuneration made available until the date of termination and stop all ongoing activities;
- 16.4.2 refund to IUCN any advance payments received in excess of the total expenditure incurred as evidenced in the invoices submitted to IUCN.
- 16.4.3 reimburse IUCN for any expenditures made in breach of the terms of this Agreement and
- 16.4.4 submit final technical and financial reports and any other materials, deliverables, works or other outputs created as at the date of termination under this Agreement.

#### 17. APPLICABLE LAW AND DISPUTE RESOLUTION

- 17.1 The performance and interpretation of this Agreement will be subject exclusively to the laws of Switzerland, excluding its conflict of laws principles.

- 7.2 The Consultant warrants that his/her performance of the Services under the terms of this Agreement will not infringe on the rights of any third party or cause him/her to be in breach of any obligation towards a third party.
